4. Claims shall be preferred in Form III and objections in Form IV or Form IV-A appended to this notice and must be signed by the claimant or objector or by his/her duly authorized agent ; copies of the forms will be supplied free by the Chief Executive Officer.

5. Claims and objections may be presented to the Chief Executive Officer at any time during office hours or sent by post but it must reach him within twenty days of the date of issue of this notice.

6. Claims and objections which are not preferred in the proper form or are not received by the date prescribed will be rejected.

7. All claims and objections received in time and in proper form will be heard by The President, Cantonment Board, Barrackpore or his nominee [some other person not being an elected member, the Chief Executive Officer or a Servant of the Board – Please See Rule 16(1) of the E.R-2007] at the Office of the Cantonment Board, Barrackpore on / between 07.08.2020 and 22.08.2020 .
